

2018 SEARCH FOR HUWARANG OVERSEAS PAMILYA PILIPINO AWARD (HOPPA) IN THE WESTERN REGION OF THE KINGDOM OF SAUDI ARABIA

In celebration of the Family Week in September, the Philippine Consulate General (PCG) and the Department of Social Welfare and Development through the Office of the Social Welfare Attache in Jeddah, Kingdom of Saudi Arabia (KSA) are pleased to announce that the search for the 2018 Huwarang Overseas Pamilya Pilipino Award in the Western region of Saudi Arabia is now open.

The HOPPA is a joint project of the Philippine Consulate General and the Office of the Social Welfare Attache in Jeddah that aims to recognize and pay tribute to an OFW family in the Western region of Saudi Arabia that has maintained strong family ties, demonstrated traditional Filipino values, and created a positive impact in the community where they live, local and overseas, in spite of the many challenges of living abroad.

GENERAL PRE-QUALIFYING CRITERIA:

1. The contest is open to every OFW family in the Western region of KSA. The family must consist of a father, mother and child/children, OR a Solo Parent (as defined under R.A. 8972, also known as the "Solo Parents' Welfare Act of 2000, Section 3.a) and child/children; Provided, that the child and/or at least one (1) of the children is living with the father/mother or solo parent, as the case may be.
2. Furthermore, the OFW family must possess the following qualifications –
 - a. Must have resided in the Western region of KSA for at least five (5) years;
 - b. Enjoys good standing in the community with no derogatory records and has not been charged of any administrative, criminal or civil cases involving moral turpitude in the last 5 years at the home and host country.
 - c. Has not violated any laws of the home and host country.
 - d. Has no pending criminal record in the home and host country.
 - e. Income is not derived from illegal sources (please provide proof of employment, e.g. employment certificate, business license, salary certificate, etc).

WHO MAY NOMINATE:

Any OFW or Filipino community organization in the Western region of KSA may nominate an OFW family for the Award. However, the nomination must include at least 2 endorsements from any recognized organization and/or sector in the Western region, including other Filipino community organizations, Philippine schools or other reputable institutions, business groups or industry associations, etc. An endorsement letter from the employer of any member of the OFW family may also be submitted.

REQUIREMENTS FOR NOMINATION:

1. A write-up (no more than 800 words) about the OFW family, in English or Tagalog.
2. Copies of awards and Certificates won by the OFW family and/or any of the children.
3. NSO-issued and DFA-authenticated marriage certificate and birth certificate of the child/children.
4. Certificate of good standing from the organization to which the father or mother or solo parent belongs, if applicable.
5. Family photo and their activities in the community, as well as photos of child/children in school and extracurricular activities.
6. NBI clearance of the father and mother, or solo parent, as the case may be.
7. Saudi Police Clearance
8. NSO-issued and DFA-authenticated Advisory on Marriage

All nominations with supporting documents must be submitted to the Office of the Social Welfare Attache, 2nd Floor, Building 4, at the Philippine Consulate General in Jeddah. The deadline for the submission of nominations is on 26 August 2018.

ANNOUNCEMENT OF THE WINNER

The winning OFW family will receive a Plaque of Recognition, cash award, and other incentives (including automatic nomination in the OWWA Model OFW Family of the Year Award) to be presented during the celebration of the Family Week Culminating Program at the PCG Hall in the last week of September 2018.

Regarding the **1st General Pre-Qualifying Criteria**, everyone is informed that the provision is amended, as follows:

GENERAL PRE-QUALIFYING CRITERIA

1. The contest is open to every OFW family in the Western region of KSA. The family must consist of a father, mother and child/children, OR a Solo Parent (as defined under R.A. 8972, also known as the "Solo Parents' Welfare Act of 2000, Section 3.a) and child/children; Provided, that the child and/or at least one (1) of the children is living **or has lived** with the father/mother or solo parent, as the case may be, **in the Kingdom of Saudi Arabia**.

Regarding the **NBI Clearance as a Requirement for Nomination**, the Consulate wishes to inform all concerned that in lieu of an NBI Clearance, a sworn statement signed by the nominated parents / solo parents will be accepted. The Sworn Statement must contain the following provisions:

1. Affiant/s has/have not been charged of any administrative, criminal, or civil cases involving moral turpitude at the home or host country;
2. Affiant/s has/have not violated any laws of the home and host country; and
3. Affiant/s has/have no pending criminal record in the home and host country.
